#### 1. Call Meeting to Order

Chuck Burns, President, called the meeting to order at 8:00 a.m.

#### 2. Public Comments

No public comments were made.

#### 3. <u>Discuss & Act on Minutes of July 25, 2011, Regular Meeting</u>

Chuck Burns presented to the Board the minutes of the July 25, 2012, regular meeting of the Kenedy County Groundwater Conservation District

Homero Vera moved and Daniel Butler seconded the motion; the motion was passed unanimously that the July 25, 2012, regular meeting minutes be passed as presented.

Andy Garza, General Manager, reported to the Board of Directors as follows:

- a. <u>Brush Country GCD Public Hearing on Proposed Management Plan</u>: The Brush Country GCD will hold a public hearing on its proposed Management Plan on August 31, 2012, at 9:00 a.m. in Falfurrias, Texas.
- b. <u>Chapter 356 Pre-Publication Draft Rules</u>: A copy of the pre-publication Chapter 356 draft rules were presented to the Board of Directors.
- c. <u>District Management Plan</u>: The TWDB has acknowledged receive of the Kenedy County GDC's revised Management Plan.
- d. <u>Region N Meeting</u>: The agenda for the Region N Water Planning Group meeting scheduled for August 16, 2012, in Robstown, Texas, was provided to the Directors.
- e. <u>Bylaws Signature Page</u>: The signature page for the revised Bylaws needs to be signed by the President and Secretary of the Board.
- f. <u>Conservation Education Materials for Fall 2012</u>: Educational kits on how aquifers function will be ordered from the Groundwater Foundation at a cost of \$24.95 each.
- g. Other: It was reported that a new computer has been purchased by the District. Also, a news article on how oil and gas companies are becoming creative in acquiring water for the fracking process.

Craig Weiland moved and Daniel Butler seconded the motion; the motion was unanimously passed that Andy Garza is authorized to purchase 10 JUG kits for the schools in Sarita, Riviera, Santa Gertrudis and Willacy County.

## 5. Receive Reports on Hydrostatic Levels and Water Chemistry for Summer 2012

Andy Garza, General Manager, reported to the Board of Directors that he had completed the hydrostatic level measurements and water chemistry analysis and that reported samples from wells that showed high levels of total dissolved solids will be collected and taken to the Test America Lab in Corpus Christi, Texas, for further analysis.

This being a report only, no vote was needed and none was taken.

## 6. <u>Discuss & Act on Authorizing Execution of Audit Letter to John Womack & Co., P.C.</u>

Leo Villarreal presented to the Board of Directors an audit letter that Chuck Burns needed to sign addressed to John Womack & Co., P.C. regarding the 2011 Audit.

Homero Vera moved and Craig Weiland seconded the motion; the motion was unanimously passed that Chuck Burns is authorized to sign the letter to John Womack & Co., P.C. regarding the 2011 Audit.

#### 7. Receive Luke Womack and Discuss & Act on the District's 2011 Audit

Luke Womack with John Womack & Co., P.C. presented the 2011 Audit to the Board of Directors, with the exception of a budget amendment that needs to be noted. Mr. Womack reported that the District had fared well as per the audit.

Homero Vera moved and Craig Weiland seconded the motion; the motion was unanimously passed that the 2011 Audit be accepted as presented.

#### 8. Conduct 2013 Budget & 2012 Tax Rate Workshop

Chuck Burns informed the Board of Directors of the need to conduct a 2013 Budget Workshop. Each budget line item was addressed and budgeted a dollar amount. The proposed 2013 Budget is \$215,494.48 and the proposed 2012 Tax Rate is \$0.0153 per \$100 valuation.

This being a workshop only, no vote was needed and none was taken.

## 9. <u>Discuss & Act on Proposed 2013 Budget and Publish Public Hearing as</u> Required by Law

Chuck Burns informed the Board of Directors that a Public Hearing needed to be set and held on the proposed 2013 Budget of \$215,494.48.

Homero Vera moved and Craig Weiland seconded the motion; the motion was unanimously passed that a Public Hearing be held on September 7, 2012, at 8:00 a.m. regarding the proposed 2013 Budget.

## 10. <u>Discuss & Act on Proposed 2012 Tax Rate and Publish Public Hearing as Required by Law</u>

Chuck Burns informed the Board of Directors that a Public Hearing needed to be set and held on the proposed 2012 Tax Rate of \$0.0153 per \$100 valuation.

Craig Weiland moved and Homero Vera seconded the motion; the motion was unanimously passed that a Public Hearing be held on September 7, 2012, at 8:00 a.m. regarding the proposed 2012 Tax Rate.
