1. Call Meeting to Order

Edward Bordovsky, President, called the meeting to order at 1:30 PM and announced that a quorum was present.

2. Public Comments

No public comments were offered.

3. <u>Discuss & Act on Minutes of September 17, 2025 Regular Meeting</u> And September 30, 2025 Special Meeting

Edward Bordovsky presented the Directors with the September 17, 2025 regular meeting minutes and September 30, 2025 special meeting minutes.

Verl Cash moved and Esteban Lopez seconded the motion; the motion unanimously passed to approve the minutes of the September 17, 2025 regular meeting and September 30, 2025 special meeting as presented.

Andy Garza, General Manager, reported on the following:

- a. Communications: Garza reported that since the District's September 17, 2025 meeting, he had communicated with Julia Loredo, J4 Water Wells, regarding driller's reports for well drilled on the Armstrong Ranch; Dave Delaney, ranch consultant, regarding the replacement for Justin Cantu on the Rockefeller Ranch; Peggy Hunka, TCEQ communications specialist, regarding a petition submitted by Nueces county landowners for creation of GCD in Nueces County; Hidalgo County Appraisal District regarding tax rates information from the Kenedy County GCD and Mike Norell, Kenedy County landowner, regarding the TDS concentration of a water sample.
- b. Well registrations: Garza informed the Directors that the Armstrong Ranch had registered 2 wells since the meeting of September 17, 2025.
- c. Brush Country GCD meeting: Garza reported that the Brush Country GCD will hold a meeting on October 28, 2025.
- d. Duval County GCD meeting: Garza stated that the Duval County GCD will meet on October 22, 2025.
- e. Nueces SWCD: Garza informed the Directors that he had provided information on the creation of GCDs in Texas to the directors of the Nueces SWCD on September 29, 2025 in Robstown, TX.
- <u>f. Public Information Act/House Bill 4214:</u> Garza reported that the Kenedy County GCD had submitted contact information as required by House Bill 4214.
